 - "(1) early-phase grants to fund the development, implementation, and feasibility testing of a program that prior research suggests has promise, for the purpose of determining whether the program can successfully improve student achievement or attainment for high-needs students;
 - "(2) mid-phase grants to fund implementation and a rigorous evaluation of a program that has been successfully implemented under an early-phase grant or other effort meeting similar criteria, for the purpose of measuring the program's impact and cost effectiveness, if possible using existing administrative data; or
 - "(3) expansion grants to fund implementation and a rigorous replication evaluation of a program that has been found to produce sizable, important impacts under a mid-phase grant or other effort meeting similar criteria, for the purpose of determining whether such impacts can be successfully reproduced and sustained over time, and identifying

3	"(b) ELIGIBLE ENTITY.—In this section, the term el-
4	igible entity means any of the following:
5	"(1) A local educational agency.
6	"(2) A State educational agency.
7	"(3) A consortium of States educational agen-
8	cies or local educational agencies.
9	"(4) A State educational agency or a local edu-
10	cational agency, in partnership with—
11	"(A) A nonprofit organization.
12	"(B) A small business.
13	"(C) A charter management organization.
14	"(D) An educational service agency.
15	"(E) An institution of higher education.
16	"(e) Rural Areas.—In awarding grants under sub-
17	section (a), the Secretary shall ensure that not less than
18	25 percent of the funds for any fiscal year are awarded
19	for projects that meet both of the following requirements:
20	"(1) The grantee is—
21	"(A) a local educational agency with an
22	urban-centric district locale code of 32, 33, 41,
23	42, or 43, as determined by the Secretary;

4	"(2) A majority of the schools to be served by

8	"(d) Matching Funds.—In order to receive a grant
9	under subsection (a), an eligible entity shall demonstrate
10	that the eligible entity will provide matching funds in an
11	amount equal to 10 percent of the funds provided under
12	a grant under this part, except that the Secretary may
13	waive the matching funds requirement, on a case-by-case
14	basis, upon a showing of exceptional circumstances, such
15	as—
16	"(1) the difficulty of raising matching funds for
17	a project to serve a rural area;
18	"(2) the difficulty of raising matching funds in
19	areas with a concentration of local educational agen-
20	cies or schools with a high percentage of students
21	aged 5 through 17—
22	"(A) who are in poverty, as counted in the
23	most recent census data approved by the Sec-
24	retary;

1	"(B) who are eligible for a free or reduced
2	priced lunch under the Richard B. Russell Na-
3	tional School Lunch Act;
4	"(C) whose families receive assistance
5	under the State program funded under part A
6	of title IV of the Social Security Act (42 U.S.C.
7	601 et seq.); or
8	"(D) who are eligible to receive medical as-
9	sistance under the Medicaid program; and
10	"(3) the difficulty of raising funds in des-
11	ignated tribal areas.
12	"(e) AUTHORIZATION OF APPROPRIATIONS.—There
13	are authorized to be appropriated to carry out this section
14	such sums as may be necessary for each of fiscal years
15	2016 through 2021.".
